Construction is underway to expand the junior school with boarding facilities for vulnerable children. Future plans include a medical center, vocational training facilities, staff housing, and accommodations for mission teams—further advancing Mifik's mission of child transformation, education, and holistic community development.**

**Child Transformation Program empowers vulnerable children through education, mentorship, healthcare, and life skills training to break the cycle of poverty and become responsible leaders. Graduates give back, creating a positive impact in their communities.**
